If you moved from Stone County before January 1st you will not owe taxes in Stone County. Please return this list stating your new address and date moved.

Failure to return your Assessment List will result in a Penalty. Late Personal Property Lists - Sec. 137.280 of SB 62 requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the first day of March.

Mobile Homes will continue to be valued by the same method, assessed at the same 19% of value, therefore this new law will not affect the amount of taxes you pay.
